



Waiver of Liability

Parental Consent for Child or Minor Participant, and Indemnity Agreement

PLEASE READ THE FOLLOWING CAREFULLY. If you have any questions, have them answered by a Toronto Outdoor Club ("TOC") volunteer BEFORE signing this document.

I, _____ the custodial parent and/or legal guardian of _____, age _____, born _____, have read and understood the TOC's Waiver of Liability for individual members, a copy of which is attached hereto as Schedule 'A' and signed this day by me in respect of my own participation in TOC events.

Further to the signing of my own TOC Waiver of Liability, I would like the above-named child/minor to participate with me in the following TOC event, which is open to children:

Therefore, in consideration of the participation of the above-mentioned child/minor in the specified Toronto Outdoor Club event, which participation I hereby expressly CONSENT to, I agree to waive, release and indemnify the Releasees--being the Toronto Outdoor Club, the executive members of the Toronto Outdoor Club, event organizers of the Toronto Outdoor Club, and general members of the Toronto Outdoor Club community--in accordance with the terms set out in the TOC's standard Waiver of Liability (Schedule 'A'), from all liability for any loss, damage, injury or expense that the above-named child/minor, or I, or both of us, may suffer as a result of the child or minor's participation in any part of this Toronto Outdoor Club event.

I understand, moreover, that this "Parental Consent for Child or Minor Participant, and Indemnity Agreement", extends to all risks associated with the event or activity in question, and all losses, damages, injuries or expenses resulting from the negligence, gross negligence or negligent rescue by those associated in any way with the Toronto Outdoor Club.

I am aware that by signing this agreement and providing my written consent to the child's participation in the specified TOC event--after having consciously and carefully put my mind to the meaning of this document and the child's level of maturity and capacity to participate safely and responsibly in the said event--I am hereby expressly waiving substantial legal rights that the child and I, our respective heirs, executors, administrators and next of kin may have against the Releasees as a result of the child or minor's participation in the event, and that in so doing I am knowingly giving up my right and the child's/minor's right to sue anyone associated in any way with the Toronto Outdoor Club in negligence for damages if I and/or the child/minor should ever be injured in the course of the child's participation in the specified TOC event.

I further acknowledge that, in participating with the named child/minor in a designated TOC event that is open to children/minors, I shall be directly and fully responsible for ensuring that both I and the child/minor at all times completely abide by all TOC policies and procedures, and participate in the event safely, and that any failure to do so by me or by the child, for whose conduct I shall be directly responsible and accountable, may result in the immediate expulsion of me and the child from the TOC event in question by the TOC Event Coordinator leading the event, and possibly in a termination or suspension of my membership in the TOC.
